

Director RD & PR apprised the members that Worthy Chief Secretary (H.P) during a meeting on Swarnim Himachal held on 25th August 2021 had desired that as part of the Swarnim Himachal celebrations one Mega event be conducted as Shashkht Mahila Diwas where women of SHGs be brought on a single platform to highlight the women empowerment in Himachal Pradesh. It was desired by worthy CS that a co-ordination meeting be held between WCD, JICA Forest and RD to decide on the date and modalities of the Shashkht Mahila Diwas and the same be communicated to GAD to make it part of the 51 programmes scheduled as part of the Swarnim Himachal celebrations.

It was decided in the meeting that the event should be held on 15th October, 2021 as the same is celebrated internationally as International Rural Women's Day. It was also decided that one location be identified in the state where the Hon CM can chair the function and various remote locations can be connected virtually.

It was apprised by the Director RD & PR that there are 26,000 SHGs registered in the state out of which approximately 17,000 are active. It was apprised by CPD JICA that around 100 SHGs are part of their JICA project. Similarly, it was informed that Shashkht Mahila Kendras have been made operational by WCD in all Panchayats of the State.


