Instructions to Bidder

I. General Instructions

- The organization (bidder) shall bear all costs associated with the preparation and submission of its proposal and PIHPFEM&L will in no case be responsible or liable for these costs, whether the proposal is finally accepted or not.
- Proposal validity shall be for 120 days.
- The organization (bidder) should submit their Bid Proposal, with supporting documents in the prescribed formats only. The Bid Proposals should be sent by registered post/courier service, along with Demand Draft of Rs 5000/- as tender/bidding document fee (non refundable) and Rs. 2,90,000/- (Rupees Two Lakh Ninety Thousand only) in the form of FDR of any nationalized Bank, as Bid Security (refundable), payable to CPD cum CEO of Society for Improvement of Forest Ecosystems Management & Livelihoods in Himachal Pradesh, Potters' Hill, Summer Hill, Shimla-5, Himachal Pradesh payable at Shimla.

 and indefinite expression such as "Subject to immediate acceptance", "Subject to prior sale"
 etc. will not be considered.
- Participating firms shall carefully examine the Proposal documents and the technical specification and fully inform themselves as to all the conditions and matters, which may in any way, affect the work or the cost thereof.
- Submitted forms, with overwritten or erased or illegible rate or rates not shown in figures and words in English, will be liable for rejection. II. Particular Instructions:

- The project field areas in Himachal Pradesh are situated in tough hilly/ mountainous terrain. Bidders are requested to get them acquainted with general topography/ terrain conditions of the project area, meticulously go through the scope/ deliverables and correctly assess the project requirements while submitting their offer.
- The bidding firm will have to specify the methods of data collection & generation of both primary and secondary nature. The firm would be required to submit, in detail, the methodology proposed to be adopted by the firm in carrying out the assignment, to meet the desired objectives.
- The firm/organization well versed with contemporary environment and social management through screening, managing and monitoring environmental and social risks and having sufficient experience of carrying out such assignments would be preferred for the job. Preference shall also be given to firms having experience in the field of environment and social management in forestry/relevant projects in India.
- The selected firm is to deploy all necessary resources such as trained and experienced man power with local transport as may be required for smooth and timely execution of the tasks.

The Proposal evaluation will be a Quality and Cost based Selection, giving weightages as per following details: -

Technical Proposal: 80%Financial Proposal: 20%

The Proposal shall be evaluated in a two-stage process.

Stage 1:

Technical evaluation, based on past experiences and technical expertise, shall be carried out for eligible bidders by assigning Technical Scores as specified below:

Minimum marks for qualifying in Technical Evaluation would be 60 marks.

Stage-2

Financial Proposals shall be evaluated only of those bidders who score at least 60 marks out of 100 in Technical Proposal evaluation. The lowest evaluated Financial Proposal will be given the maximum financial score of 100 points. The financial scores (F_n) of the other technically qualified Financial Proposals will be computed as per the formula given below:

Bids will be ranked according to their combined technical (T_n) and financial (F_n) scores using the weights $W_T = 0.80$ (the weight given to technical proposal); $W_F = 0.20$ (the weight given to the financial proposal). The combined technical and financial score (S) for the bidder under consideration shall be computed as per the formula given below:

Terms of Reference (ToR)

For

Environmental and Social Considerations for environmental and social safeguard assignment

1. Background and Context

Japan International Cooperation Agency (JICA) assisted "Project for Improvement of Himachal Pradesh Forest Ecosystems Management and Livelihoods" (PIHPFEM&L) aims at contributing to eco-restoration and development of forest resources through sustainable forest ecosystem management, biodiversity conservation, livelihood improvement support for the target community and institutional capacity strengthening. The project period is 10 years from 2018-19 to 2027-28. The Project is being implemented by **Society for Improvement of Forest Ecosystems Management & Livelihoods in Himachal Pradesh** (registered on 09-07-2018 under HP Societies" Registration Act 2006). The activities will be carried out both in Participatory Forest Management (PFM) as well as departmental mode through 400 Village Forest Development Societies (VFDS) and 60 Biodiversity Management Committees (BMC) sub-committees.

The Environmental and Social Assessment Framework (ESAF) has identified a number of environmental and social safeguard issues and provided overall guidance on their avoidance, management and mitigation. In order to fully respond the requirement of ESAF, i.e. JICA Guidelines and relevant legal framework in India and HP state, an external agency for the above services is required to be hired by PMU for the provision of more detailed and specific guidance, capacity development and follow-up during project implementation.

HPFEM&L or HPFD does not have any system for environment and social management, for screening, managing and monitoring environmental and social risks. Thus, it is recommended in the project document to employ additional experts by PMU for this work and their services spread for seven years with only working for few months in these years. In the second Governing Body meeting of the Project it was decided that since it seems impractical to engage the experts with their services spread over a long time period, it is requested that the Project may be allowed to hire consultancy for the above services rather than hiring individual experts. Accordingly, on approval by Governing Body, the issue was referred to JICA, who have conveyed their approval on dated December 06, 2019.

In the course of the design and implementation of the Project, two vulnerabilities within the society require to be carefully considered, that is, Environmental and Social vulnerabilities. Environmental vulnerability is a condition when the integrity of ecosystem is threatened by human activities or interference and/or natural causes, which could occur over spatial or temporal scales. Vulnerability could possibly increase with the intensity and frequency of human interventions and/or natural hazards. Social vulnerability is the helplessness or defencelessness of an individual or group of people who are typically socially excluded, underprivileged, often discriminated against and restricted to access benefits of development or opportunities offered through socio-economic enhancement schemes. Their social

characteristics such as identity and social status, culture, economic status and practices, and social institutions, often results in their discrimination and segregation from the main stream.



2. Objectives:

- 1. To facilitate and coordinate with various implementation and line departments for smooth implementation of ESAF (The Environmental and Social Assessment Framework) /VSTPF (Vulnerable Scheduled Tribes Planning Framework)
- 2. To update and finalise ESAF/VSTPF,
- 3. To develop appropriate training materials on environmental and social safeguards, following the requirements in ESAF,
- 4. To provide training courses and capacity enhancement of selected participants, at the different levels of stakeholders who will be designated with additional responsibility to ensure implementation of environment and social safeguards, and
- 5. To supervise/ manage the project activities to ensure that the required procedures indicated in ESAF are followed properly. The consultancy may also be required to follow-up in the field where particular issues are identified and reported.

3. Scope of work

The PIHPFEM&L in the selected project area are expected to have mostly positive environmental impacts. Further, the Project is anticipated to bring social benefits for locals including vulnerable groups such as the poor, landless/landed poor, Scheduled Tribes (ST), Scheduled Castes (SCs), Other Backward Classes (OBC), etc. in the project area. However, the Project could possibly lead to potential negative environmental and social impacts as well. In this regard, ESAF is prepared to assess the potential negative impacts and ensure that such impacts are safeguarded against in accordance with JICA's policies on environmental and social considerations in development projects, as well as relevant policies, laws and regulations of the country and the state.

Overview and Positions of Safeguards Instruments

Basically, the Project is not anticipated to involve any significant adverse environmental impacts and nor will it involve any loss of land, resettlement or livelihoods. However, there are still possibilities to cause negative environmental and social impacts when detail activities of Sub-projects are defined at the project detailed preparation/implementation phase. Therefore, the below two frameworks are proposed to ensure the mitigation of the negative impacts, and to guarantee social safeguard measures.

(a) Environmental and Social Assessment Framework

In the Project, "Environmental and Social Assessment Framework (ESAF)" shall be applied as the nature of the framework is not only focused on the environmental aspects.

Unlike a typical infrastructure project, this Project is anticipated to have multi-sectoral interventions and activities, being implemented at several sites with many Sub-projects and many of these Sub-projects are yet to be defined in detail (site location, size/scope of the activity). In these circumstances, it would be impracticable at this stage of project preparation to assess the environmental and social impacts and propose detailed

management and mitigation measures. However, it would be possible to assess the broad types of activities proposed and provide guidance, and outline procedures to manage and mitigate potential risks associated with the activity during implementation. Therefore, an assessment framework guiding the appropriate management and mitigation measures against environmental and social risks is prepared. The main safeguards instrument will be this ESAF that fully considered the existing environmental and social management systems in Indian and HP state as well as the JICA requirements.

(b) Vulnerable Scheduled Tribes Planning Framework

In the Indian context, the term "Scheduled Tribe (ST)" is applied to refer "Indigenous Peoples" as used by JICA and other multilateral funding agencies, such as World Bank, Asian Development Banks, etc. And this framework shall be particularly applied to Scheduled Tribes (STs) and Forest Dwellers as per The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 with only focused on the individuals/communities who could be severely affected their daily lives by project activities. Among the two social groups, the number of forest dwellers would be quite small due to the slow progress of the FRA implementation in the state, therefore, the name of the framework is replaced as "Vulnerable Scheduled Tribes Planning Framework" (VSTPF).

For the above targeted social groups, guidance for specific measures shall be provided under the framework which may be required in addition to the provisions of ESAF. Other vulnerable groups including poor households, the landless, women as well as deprived classes, such as the Scheduled Castes (SCs) and Other Backward Classes (OBCs) population are considered well in ESAF to ensure the opportunities for effective consultation, participation, receive appropriate benefits and are overall not adversely harmed by the Project.

The main objectives of VSTPF are (i) to ensure the targeted social groups, affected by any additional project interventions, will receive culturally appropriate social and economic benefits from the Project, (ii) to ensure their participation in the entire process for the preparation, implementation and monitoring of project activities, and (iii) do not suffer any adverse impacts as a result of the Project.

Target Social Groups of ESAF

ESAF will be applicable to all communities and people within the project area with well consideration on the depressed/ vulnerable groups to ensure their participation in the course of the project implementation and include as beneficiaries, receive appropriate benefit and avoid/mitigate any impacts affected by the Project. Table 1 indicates the key groups for ESAF to address environmental and social considerations. It should be noted that an individual or household may be categorized into more than one of the categories below;
